
- Identifying what assets are in an estate and obtaining valuations

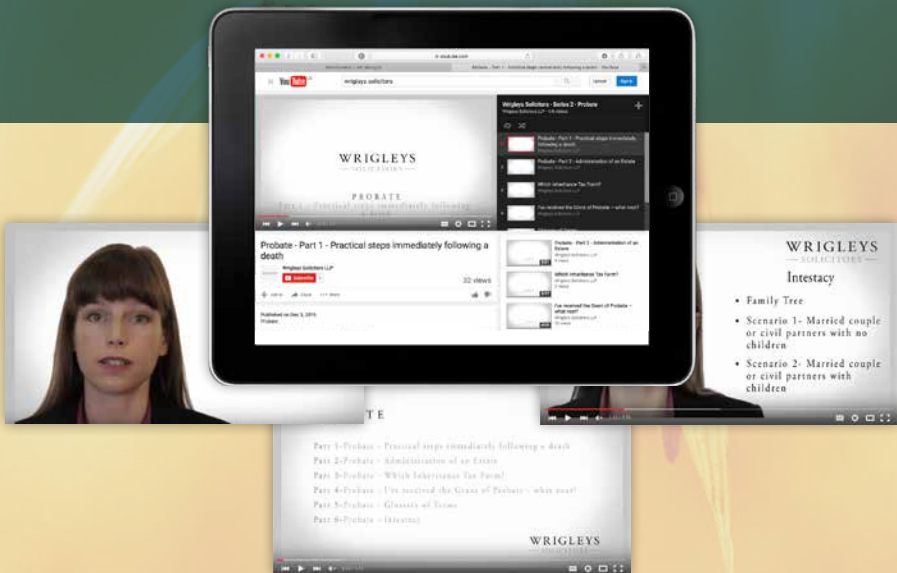

# Practical steps immediately following a death

- 1. Register the death** – Make an appointment with the Registrar at your local registry office.
- 2. Look for a Will** – Is there a Will at home or stored with a firm of solicitors?
- 3. Secure the property** – Is the family home empty? Contact the insurers to let them know and check if they have any extra requirements.
- 4. Council Tax** – Contact the local council tax office to see if council tax can be reduced or waived.
- 5. Redirect post** – both for security of the property and to collect information for the probate.
